3. Single country and large market capitalisation companies exposure

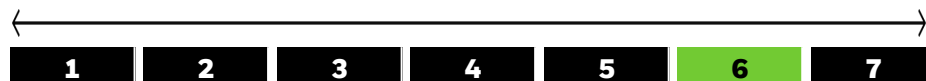

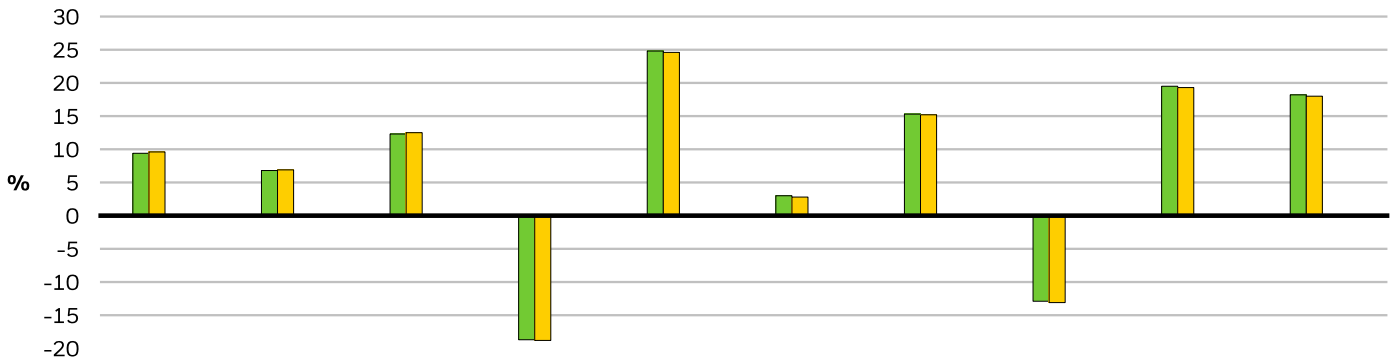

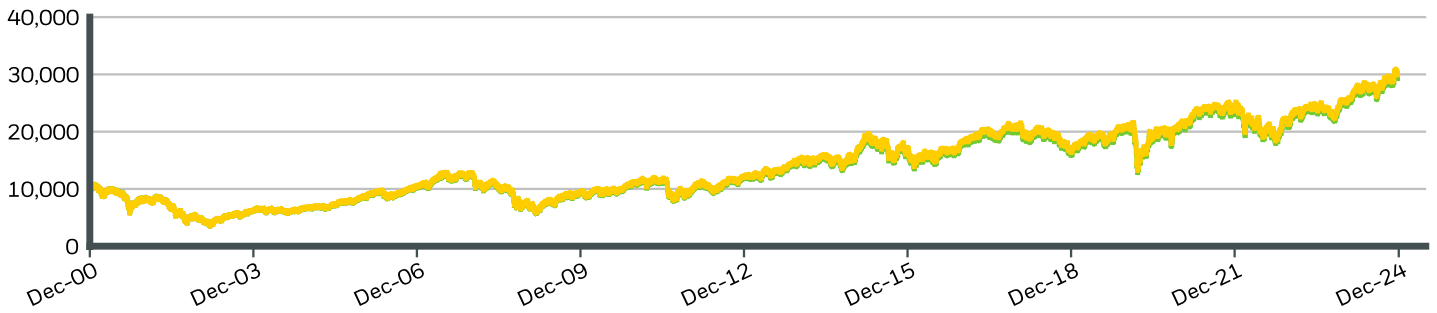

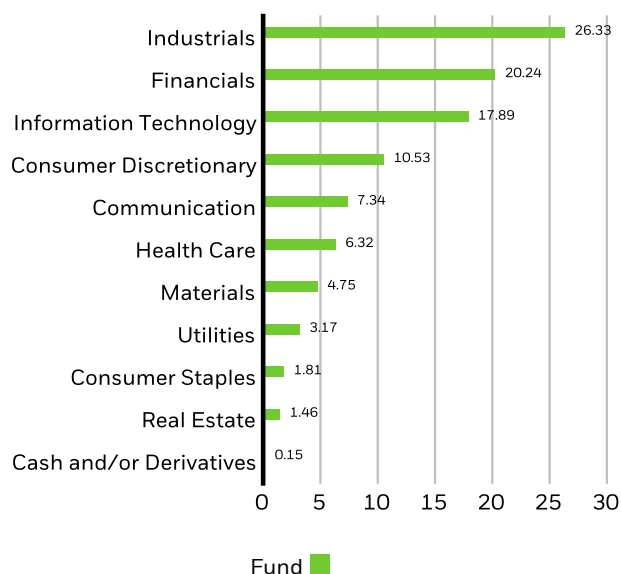
